

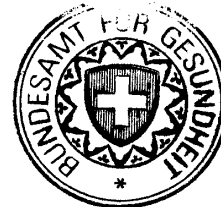
The afore mentioned product is registered with the Swiss Federal Office of Public Health, Berne, Switzerland under control number BAG T 57760.
